AGREEMENT

ON BILATERAL COOPERATION BETWEEN INSTITUTION OF EDUCATION "BARANOVICHI STATE UNIVERSITY"

(Baranovichi, Belarus)

and

CANAKKALE ONSEKIZ MART UNIVERSITY

(Canakkale, Turkey)

IE "Baranovichi State University" (Baranovichi, Belarus) and Canakkale Onsekiz Mart University (Canakkale, Turkey), with the purpose of developing bilateral cooperation in scientific research, academic, educational, public and cultural activities, hereby have concluded this agreement on the following:

1. Orientation of Cooperation

To develop scientific research, academic, educational, public and cultural activities, the universities shall cooperate along the following lines:

- 1.1. Organizing and conducting joint scientific seminars, conferences, symposiums, etc.
- 1.2. Developing and conducting joint scientific and research projects; organizing scientific and research teams including author-supervised groups to implement scientific research.
- 1.3. Exchanging the results of scientific research, developed resources, publications and teaching materials.
- 1.4. Exchanging practical experience of using advanced technologies and methods of teaching; providing mutual assistance in training researchers.
- 1.5. Exchanging lecturers, young researchers and other university staff to deliver lectures, to master the latest technologies and methods of scientific research and to improve educational work.
- 1.6. Organizing student exchange to acquire a better knowledge of the history, culture, education and other aspects of the life in the Republic of Belarus and Turkey.

2. Terms of Cooperation

The intended guidelines of cooperation shall be implemented on the following terms:

2.1. The joint projects shall meet the requirements of both parties and be subject to mutually beneficial conditions.

- 2.2. The joint scientific research shall be conducted on mutual agreement between faculties, departments and university staff coordinated by the universities' governing bodies.
- 2.3. Intellectual property rights on the results of joint activities will belong to both Parties, unless agreed otherwise.
- 2.4. Lecturers, students and administrative staff exchange shall be based on individual invitations forwarded by the parties to each other.
- 2.5. Expected costs in relation to mobility of personnel (lecturers, students, administrative staff) and, in general, to the activities planned in the project itself (conferences, seminars, etc.).
- 2.6. Travel costs and mission expenses have to be paid by the home university, whilst board and lodging are to be paid by the host university, if specific funds are available for this purpose.
- 2.7. The host university will assist students in finding accommodation at halls of residence and similar structures, as well as allow them access to canteens and other services provided by the university to its own students.

3. Other Terms

- 3.1. The Agreement shall come into force after it has been signed, and shall be valid for 5 years.
- 3.2. The parties shall be entitled to cancel this agreement unilaterally sending a written notice to the other party 2 months prior to its cancellation.
- 3.3. Any changes in or supplements to this agreement shall be valid provided they are done in writing and signed by the authorized persons.
