

AGREEMENT OF COLLABORATION

**Canakkale Onsekiz Mart
University, Turkey**

and

**Saint Petersburg Stieglitz State
Academy of Art and Design, Russia**

(individually "Party", together "Parties")

Canakkale Onsekiz Mart University and Saint Petersburg Stieglitz State Academy of Art and Design have agreed to sign the following Agreement with the purpose of fostering cooperation, mutual understanding and development in the fields of education and research.

Article 1

The Parties recognise that each of them is pursuing educational, research, cultural and training activities in various areas of common interest and shall engage in collaboration in the following types of cooperation:

- 1.1 Development and implementation of joint research activities;
- 1.2 Accepting professionals (academic staff) through integration activities initiated by either of the institution;
- 1.3 Joint workshops, seminars and symposiums, mutual visits;
- 1.4 Student and teacher exchange;
- 1.5 Exchange of scholarly publications and other information in areas of interest to both parties.

Article 2

- 2.1 In the frame of the collaboration agreement Parties will, in particular, endeavour to promote cooperation in exchanging academic staff, researchers and students.
- 2.2 The sending institution will nominate the exchange candidate. The duration of exchange will be determined by mutual consent.
- 2.3 Both parties undertake to abide by the bilaterally agreed terms of this cooperation agreement but will reserve the right to choose the incoming students and staff based on their level and available staff resources.

Article 3

- 3.1 Both Parties will designate individuals with responsibility for the of this agreement.
- 3.2 Both Parties are responsible for implementation of the collaboration agreement;
- 3.3 Both Parties understand that all the financial agreements will have to be negotiated and will depend on the availability of funds.
- 3.4 Neither party is obliged to provide financial support for visiting scholars

Article 4

- 4.1 The present agreement will be supplemented by more detailed working plans (subagreements between faculties and departments) prepared periodically as required by current or planned projects.
- 4.2 Each university will nominate a representative who will be responsible for the working plans, and all matters related to the implementation of the agreement.



Article 5

- 5.1 The agreement will be valid for a period of five years, commencing from the date of signing by both parties and automatically renew itself for another five years.
- 5.2 This agreement may be terminated with six months prior written notice to the other party, without prejudice to the completion of ongoing projects agreed in the working plans.

- 6.1 This agreement has been prepared in English and each party will retain one original copy.
