## Contributor Guidelines

- The Turkish Yearbook of Çanakkale Studies is a peer-reviewed journal indexed by international indexes. It is being published twice a year, in April and October. It accepts authentic research papers, book reviews and symposium and congress announcements. Submitted papers are expected to meet scientific research criteria, to contribute a novelty to the relevant area, and not to be published in another edition. Presentations delivered at a scholarly meeting are welcome unless published. If otherwise is observed, the accepted paper shall be removed from the publication lists.
- It is a peer-reviewed journal accepting articles in Turkish and English.
- For the submission of paper in Turkish, authors are expected to observe orthographic guidelines by TDK (Turkish Language Association).
- Each illustration, table, drawing, figure included in or document appended to the paper should be enumerated and captions thereunder should be included.
- Translators are required to acquire permission from the original author of the paper. In such cases, the author of the original paper does not receive any payment.
- Submitted papers are required to contain abstracts in Turkish and English, plus keywords, which should not exceed 200 words (the main body of the text excluded). At least 3 and at most 5 keywords should be included.
- The author shall be assumed responsible for the content and the appendices (images, tables, maps, drawings, documents, etc.).
- After the evaluation of the editorial board, the submitted papers are delivered to two, or three if need be, referees specialized in the related issue. Upon the approval of the editorial board, the paper is published. The board may resolve to publish or not to publish other types of papers (e.g. symposium and congress announcement, book reviews) in its sole discretion.
- The Editorial Board reserves the right to make some minor changes in the submitted paper if needed.
- Papers returned to the authors for corrections required by reviewers should be re-submitted in no longer than one month after the corrections are made.
- If resolved unqualified for publication by the referees, the paper is returned to the author.
- The authors are not entitled to demanding any payment for copyright. One copy of the journal is sent to the author whose article is published in the journal, and another one is sent to the referees of that issue.
- The content in The Turkish Yearbook of Çanakkale Studies is protected by copyright. Copyright protection applies automatically to any original work as soon as it is written down or put into a permanent or fixed form. The Turkish Yearbook of Çanakkale Studies Institute is licensed under the Creative Commons Attribution-NonCommercial-NoDerivatives 4.0 International License. All articles published open access will be immediately and permanently free for all to read, download, copy and distribute as defined by the applied license.

This license allows users to copy and distribute the article, provided:

-this is not done for commercial purposes and further does not permit distribution of the Article if it is changed or edited in any way.

- -the user gives appropriate credit (with a link to the formal publication through the relevant DOI) and provides a link to the license but not in an any way implying that the licensor is endorsing the user or the use of the work.
- -no derivatives including remix, transform, or build upon the material was allowed for distribution.
- For open access publishing, this journal uses an exclusive licensing agreement. Authors will transfer copyright to the journal but will have the right to share their article in the same way permitted to third parties under the relevant user license, as well as certain scholarly usage rights. ## Font size and punctuation:

- Please use font size Times New Roman and sheet size A4 on software compatible with MS Word.
- Use 16 points, boldface and small cases for the title, which should be centre aligned. The text may include main title(s) and sub-titles. Please use 10 points, boldface, small cases for main titles and sub-titles, which should be left-aligned. Please use 6nk spacing below and above the titles and paragraphs.
- Authors name and surname should be written with 12nk spacing in 10 points, boldface, and surname in uppercase and right-inclined. Title, address, and e-mail address should be included at the bottom of the page in 8 points and should be marked by an asterisk (\*).
- The text should be written in 10 points, single spaced, and justified.
- Margins Top: 5,8 cm, Bottom: 5,8 cm Right: 4,5 cm Left: 4,5 cm Spacing should be 3 nk between lines, 6 nk between paragraphs, and the paragraph indentation should be 0,8 cm.
- Page numbers should be in 8 points and included at the bottom of pages.
- Quotations over 5 lines should be indented 1 cm and should be put into quotation marks and written in a 1 point smaller case. Quotations of less than 5 lines and emphasized parts should be in italics. Please use 8 points and single-spacing for footnotes, which should be justified and has a 0.5 cm indentation. Intratextual references should be footnoted and enumerated starting at 1.

Citations and Bibliography:

Our journal accepts two different citation and bibliography systems of intratextual and extratextual styles. The authors should choose one of these systems.

1. Extratextual Citation System

Book and journal titles in footnotes should be in italics and article titles should be included in quotation marks. In footnotes, copyright page should be fully included when cited for the first time; but should be written as abridged specified by the author. In the cases of multiple citations from books and/or articles

by the same author, author's surname, then full or abridged title of the book/article should be included after the first reference to the second work. In citations for the first time, multiple authored works should be fully presented when cited for the first time, but only the surname of the first author should be presented in later cases.
