Prof Ebersöhn is the Director of the Centre for the Study of Resilience and a professor in the Department of Educational Psychology in the Faculty of Education.

An NRF-rated researcher, Prof Ebersöhn is regarded as a leading scholar and teacher in resilience and resilience promoting interventions in high-risk school settings. Her research is positioned in contexts characteristic of an emerging economy country in transformation. She combines emancipatory and intervention methodologies to investigate pathways to resilience as human-ecological and cultural adaptive responses to chronic and cumulative adversity. Her recognised scientific contributions include a generative theory (relationship-resourced resilience) describing an emic system to counter chronic adversity, as well as 'flocking', a word she coined to depict a collectivist indigenous psychology pathway to resilience.

Prof Ebersöhn is the appointed Secretary-General of the World Education Research Association (WERA). She serves as Chair of the International Research and Scholarship Committee (Division C, Learning and Instruction, of the American Educational Research Association), and was the South African international representative to the Building Resilience in Teacher Education (BRITE) Project Reference Group, Murdoch University.

She presented a plenary session in March 2016 as an invited speaker to the Global Development Network 17th Annual Conference in Lima and at a symposium on Indigenous Pathways to

Resilience at the 2014 meeting of the American Psychological Association. She was visiting professor at Yale University and Edith Cowan University.

Her research focus has had a decided impact on curricula for teacher training in several higher education institutions in South Africa.

With students, co-researchers and as single author, Prof Ebersöhn has contributed more than 70 peer-reviewed articles, numerous book chapters and several edited and co-authored books.



Professor M.S.Rao is the Founder, MSR Leadership Consultants, India with more than three decades of experience in leadership development. He is the author of 17 books including Secrets of Your Leadership Success The 11 Indispensable E's of a Leader and is an experienced leadership educator, editor, speaker, mentor and consultant. His areas of interest include Leadership, Learning and Development and Soft Skills.

Professor Rao has published more than 250 papers and articles in international publications such as Leadership Excellence, Leader to Leader, T+D Magazine (ASTD), Personal Excellence, Chief Learning Officer Magazine, Emerald and Sage to name a few. 

Prof. Dr. Masashi Maita continues his research on risk assessment, aquatic toxicology, fish pharmacology, fish physiology and food safety.

Prof. Dr. Masashi Maita is the former Dean of the Graduate School of Marine Science and Technology. He teaches Marine Bioengineering and Fish Health Management courses at undergraduate levels. He gives lectures in Applied Marine Biosciences at graduate level in the fields of Influence of chemicals and/or environmental factors to fish health, Fish health management by natural herbs and Safety management of aquaculture fish.

To date, cost analysis in aquaculture, hormone applications, pharmacokinetics, treatment methods of fish diseases, molecular genetics applications, fish immunology, floating and submersible cage technologies, application of instrumental analysis methods, innovative fish feeding methods, toxicity, pearl production, improving cultured fish meat quality are among his research interests. He has more than 100 articles published in international journals and international books on his subjects.

Emmanouil Varvounis was born in 1966 on Samos, Greece, where he completed his primary and secondary education. He was a student of the Section for History and Archaeology of the Philosophical School of the University of Athens (1983 – 1988) and of the University of Athens Theological School. He specialized in folklore and in 1991 was awarded a doctorate in folklore by the Department of Primary Education of the University of Athens. During the period 1996 – 1997, he did post-doctoral research at the Université Catholique de Louvain (Louvain – la – Neuve) in Belgium. Since 1992 he has taught folklore in the Department of History and Ethnology of the Democritus University of Thrace, where he is today a Professor and Department Chairman. He is a member of many learned societies in Greece and abroad, such as the Hellenic Folklore Society, in Athens, of which he is also a member of the Administrative Committee, the British Folklore Society, of London, and the American Folklore Society, of Washington. He is the author of many works, some independent studies and some published in collective volumes. His works have been translated and published in English, French, Spanish, Italian, German, Serbian, Turkish, Russian, Georgian, Arabic, Armenian, Latin and Bulgarian. In March, 2005, His Beatitude the Ecumenical Patriarch Vartholomaios honoured him with the rank of 'Master Protector of Letters of the Great Holy Church of Christ'. In 2007, Priest and Patriarch of Alexandria and All Africa Theodoros II honoured him with the rank of 'Master Keeper of the Archives' of the Patriarchal Throne of Alexandria. In February 2011, His Beatitude the Patriarch of Jerusalem Theophilos III proclaimed him 'Crusader of the All-Holy Tomb'. In December 2011, he was awarded a prize by the Academy of Athens, in January of 2011 he was awarded the Gold Medal for the Arts and Sciences and in 2012 the Great Gold Cross of the International Albert Schweitzer Organization. In 2012 he was awarded an Honorary Doctorate by St. Stephen Harding University, North Carolina. He is Corresponding Member of the Accadeia Costantina (Rome, 2013), the Accademia Bonifaciana (Milan, 2014), Honorary Member of the Norman Academy (France, 2014), of the REAL Academia de Buenas Letras (Barcelona, 2015), of and a Regular Member of the International Academy of Social Sciences (Florida, 2015). He is an Accedemico d'Onore of the Real Academia Sancti Ambrosii Martyris of Portugal (2016). He is also an Honorary Doctor of Letters (LL. Doctorate, Doctor of Letters) of the Theological College and Seminary, St. Stephen Harding University (2014) and Honorary Doctor of Theology (DD, Doctor of Divinity) of the St. Seraphim School of Orthodox Theology (2015). In 2015, he was awarded the 'Great Prize' by the Institute of Pedagogical Studies and Applications for his academic work and for his contribution

to the international spread and study of Greek culture. He was also awarded the 15th International Giuseppe Sciacca Prize in 2017 and in the same year made an Honorary Professor of the Department of Classical and Modern Greek Philology (Departamentul de Filologie Clasica şi Neogreacă) of the University of Bucharest. He has been awarded many state and Church decorations for his educational and social work. He is married and the father of two sons.
