come to an

Agreement of Co-operation

On the basis of positive experience and results achieved in our present cooperation at faculty level, with the aim of subsequent extending and developing scientific and pedagogical relations.

Article I

The main objective of the Agreement on Co-operation (next merely the Agreement) is to enhance the international understanding, the educational support, scientific and cultural activities of the students and academic staff at the universities.

The collaboration will be carried out on the basis of democratic principles with the greatest respect for legality and institutional sovereignty of the two contracting parties,

During the co-operation, both the parties undertake to follow the corporate needs and wishes to achieve further scientific and cultural development of the universities concerned.

Article II

The collaboration will be carried out in the following fields:

1. supporting

- the mutual mobility of the students and the academic staff,

- summer schools,

- the designing and performing mutual scientific projects,

- the professional practice in companies,

2. publishing and reprinting joint educational, professional and scientific materials

3. holding common educational and cultural events such as congresses, conferences, panels, workshops and seminars,

4. supporting other sectional projects in the fields of economics, museology, archeology, mathematics, physics etc.

Mutual co-operation may be done at the faculty, institute and department level, on the basis of current mutual partner contacts. If need be, own partial implementation agreements will be made for realization of co-operation. They will contain precisely specified obligations and duties of both the partners.

Article III

In compliance with the usefulness, the contracting parties will make a special effort to incorporate common projects into international programmes, signed by the Czech Republic and Turkev.

Article IV

In the field of study, both the parties will encourage student's mobility of bachelor, master and doctoral study programmes in all forms of study.

If possible, the universities will make it feasible for their students to study at the host university for a particular time.

Article V

The contracting parties will favour the exchange of educational materials and information as regards the subject matter of the Agreement (information about study and scientific literature, new publications etc.)

Article VI

Every individual action has to be specified and agreed on by both the partner sides at least a month before it takes place.

Article VII

The Agreement is reached for the indeterrrinate duration. It comes into force at the day of the signing by the statutory deputies of the two institutions.

It is possible to terminate the Agreement by informing the other university in writing, namely with the six-month notice period, beginning at the very first day of the following month. Subsequently, the legal settlement of the two parties concerned must be ensured till the end of the notice period.

At one of the party's suggestion, it is feasible to make changes and amendments to this Agreement. However, it may be done merely in a written form and by the common consent.

Article VIII

Each of the contracting parties will be given one copy in the English language.

Article IX

Both the parties undertake to keep the condîtions of this Agreement. In this respect, the document is being signed by the leaders of the institutions.
