## Agreement of Academic Exchange Between National University Corporation Ehime University/Japan And Canakkale Onsekiz Mart University

(Revised Version)

National University Corporation Ehime University, Japan, and Canakkale Onsekiz Mart University, the Republic of Turkey, sign this agreement with the objective of facilitating cooperation and exchange through academic and research programs as listed below.

- 1. Both parties will strive to promote and develop cooperation in the following ways:
  - (1) Exchange of academic materials and publications
  - (2) Exchange of academic staff, research staff and students
  - (3) Cooperation in research and the presentation of its results
- 2. Both parties will pursue the objectives listed here after sufficient consultation with each other.
- 3. Expenses incurred in the implementation of the agreement shall be, as a rule, covered by the university concerned.
- 4. This agreement will be renewed on March 18 2009 and shall be valid for five years. In the event that the parties agree, it may be amended. The agreement can be terminated within the five-year term if notice is given six months in advance and if both parties agree.
- 5. This agreement is prepared in Japanese, Turkish and English and all texts shall be regarded as official. Two signed copies in each language will be prepared and both parties will keep one of each.



## National University Corporation Ehime University/Japan and

## Canakkale Onsekiz Mart University

(Revised Version)

For the purpose of insuring smooth student exchange according to Item 1-1 of the Agreement for Academic Exchange, National University Corporation Ehime University, Japan, and Canakkale Onsekiz Mart University, Republic of Turkey agree to the following terms:

- 1. Number of Students and Length of Stay
  - (1) Each university may accept no more than five students a year.
  - (2) The length of stay shall be less than one year. However, if both universities agree the term can be extended one more year.
- 2. Selection, Course of Study, Student Status
  - (1) When sending a student the home university shall choose a student according to the terms of this memorandum and send a recommendation to the host university.
  - (2) The host university will consider the proposed course of study, the purpose and ability of the student when making a decision of acceptance.
  - (3) The exchange student shall be able to make use of the library and other student facilities at the host university.
  - (4) Exchange students in this program will have the status of 'special auditor' at the National University Corporation Ehime University and 'international exchange student' at Canakkale Onsekiz Mart University.
  - 3. Academic Record and Accreditation
    - (1) The host university shall evaluate the academic performance of each student according to its rules.
    - (2) The home university may award credit to a student for the work done at the host university.
  - 4. Tuition, scholarships and other fees
    - (1) Exchange students are not required to pay examination fees, entrance fees or tuition fees at the host university.
    - (2) Both universities will actively provide information about scholarships as a form of financial support.
    - (3) Exchange Students shall be financially responsible for their own roundtrip air ticket.
