

Agreement on the Exchange of Education and Research  
between  
Canakkale Onsekiz Mart University  
and  
Joetsu University of Education  
(4th Term)

Canakkale Onsekiz Mart University, Turkey and Joetsu University of Education, Japan have agreed to establish this agreement with the purpose of fostering cooperation and mutual understanding in the fields of education and research.

1. The two universities will make efforts to promote the following exchanges within the limitation of the law in both countries.
  - (1) Exchange of scientific publications and academic materials for research and educational purposes.
  - (2) Exchange of faculty members and students.
  - (3) Contribution of collaborative research.
2. Both universities will engage in full consultation in order to carry out the principles of this agreement.
3. Necessary fees based on this agreement must be paid by each sending university.
4. This agreement will be valid for a period of five years, commencing from the date of renewal on December 5, 2020. This agreement may be amended or extended by mutual agreement of both parties. Either institution may terminate this agreement by giving at least six months written notice.
5. This agreement has been prepared in two originals and each should be in English, and each party will retain one original.

Memorandum on the Student Exchange  
between  
Canakkale Onsekiz Mart University  
and  
Joetsu University of Education  
(4th Term)

In order to promote the student exchange program smoothly, as provided in the Provision 1, No.2 of the Agreement on the Exchange of Education and Research between Canakkale Onsekiz Mart University and Joetsu University of Education, both universities agree to establish the Memorandum on the Student Exchange. This memorandum is based on the Provision 2 of the Agreement.

1. Exchange Students and the Duration of the Exchange Program
  - (1) The number of exchange students is limited to a maximum of three, per year.
  - (2) The duration of the exchange will be for a maximum of one year. However, under the agreement of both parties, the exchange students may be allowed to extend their term up to the limit of one year.
2. Selection, Learning (Research), and the Condition of the Students
  - (1) The sending university will select the suitable students for the purpose of this memorandum amongst the candidates of the exchange program, and recommend them to the host university.
  - (2) The content of the subjects required at the host university will be decided by the host university, taking into consideration the exchange students' learning (research) abilities and their purpose.
  - (3) Exchange students can use student facilities such as a library at the host university.
  - (4) Exchange students will be treated as "special audit students" at Joetsu University of Education, and as "international exchange students" at Canakkale Onsekiz Mart University.
3. Evaluation and Recognition of the Credits
  - (1) The host university will provide suitable evaluation of the subjects attended by the exchange students.
  - (2) The sending university will be able to recognize the credits taken at the host university.

4. Tuition Fee, Scholarship, and Other Expenses

- (1) Exchange students in both universities are exempt from paying examination fees, admission fees and tuition.
- (2) Both universities will make efforts to provide scholarship information in order for financial support for the exchange students.
- (3) Exchange students must pay their two way flight tickets and their expenses during their stay in the host university.

5. Accommodation

The host university will make efforts to offer a dormitory for the exchange students.

6. The Validity of the Memorandum

This memorandum will be valid for a period of five years, commencing from the date of renewal on December 5, 2020. Either institution may terminate this memorandum by giving at least six months written notice.

This memorandum has been prepared in two originals and each should be in English, and each party will retain one original.

7. Others

Items necessary to promote student exchange programs based on this memorandum will be decided upon university laws and through consultation between both universities.
