## MEMORANDUM OF UNDERSTANDING BETWEEN ÇANAKKALE ONSEKIZ MART UNIVERSITY, TURKEY AND NANZAN UNIVERSITY, JAPAN

Çanakkale Onsekiz Mart University, Çanakkale, Turkey (hereafter referred to as "COMU") and Nanzan University, Nagoya, Japan (hereafter referred to as "NU") enter into this Memorandum of Understanding ("MOU") for the purpose of strengthening, expanding and enriching cooperation in higher education that will make collaborative programs and activities possible. COMU and NU are referred to individually as a "Party" and collectively as the "Parties."

Collaborative programs and activities may include the following:

- Exchange of faculty for teaching, including joint research and development projects
- Exchange of students
- Exchange of research output and materials in fields of mutual interest; and,
- Participation in joint international conferences, seminars, lectures, various forms
  of faculty training and development, and similar academic meetings.

The specific terms of this MOU do not preclude the development of future collaborative ventures or projects not mentioned in this document.

This MOU implies that activities to be started in order to realize the aforementioned objectives shall be determined in each case through a particular Supplemental Agreement in accordance with the rules and regulations of each Party, and subject to available funding sources on the part of each of the two Parties. Each Supplemental Agreement will be appended to this MOU as a schedule, and the terms of the Supplemental Agreement will control the administration of the activity described. To the extent that the MOU and the Supplemental Agreement are ever determined to be inconsistent, the language of the Supplemental Agreement shall be deemed controlling for the purposes of the activity described in that Supplemental Agreement.

Representatives of the Parties to this MOU shall consult each other at periodic intervals to review the implementation of collaborative programs and to propose other mutually beneficial programs. Any amendment or modification of the terms in this MOU shall be done only by means of a written agreement signed by both Parties.

This MOU shall become effective on the first day after both Parties have signed the document, and shall remain in effect for five (5) years from that date or until terminated in writing by the Parties hereto, whichever shall come first. It will be automatically renewed every five years unless either Party notifies the other of its intent to terminate. Upon any such termination, any activity that may have commenced at either institution pursuant to a Supplemental Agreement before the effective date of termination may be completed, and the applicable terms of the MOU and the applicable Supplemental Agreement shall continue to govern the activity.

This MOU constitutes the entire agreement between the Parties and supersedes all prior discussions, agreements, and understandings, whether verbal or in writing.

Each Party shall designate a person or office to serve as liaison for implementing this MOU. For COMU, the contact person will be Head of International Relations Office or his/her designee. For NU, the contact person will be the Director of the Center for International Affairs or his/her designee.

Any notice to either Party hereunder must be in writing signed by the Party giving it, and shall be served either personally or by registered or certified mail, or by overnight or expedited delivery service, addressed as follows:
