



AGREEMENT OF COOPERATION

Canakkale Onsekiz Mart University (hereinafter COMU) represented by Prof. Dr. Sedat MURAT and Academy of Economic Studies from Moldova (hereinafter ASEM) represented by Mr. Grigore Belostecinic, hereinafter called Parties, aiming to promote collaboration between the two institutions have agreed to conclude the following Agreement of Cooperation.

Article 1. PURPOSE OF AGREEMENT

The purpose of the present Agreement is to establish the legal framework for cooperation between the two Parties.

Article 2. AREAS OF COLLABORATION

The contracting Parties agree to cooperate in the following activities:

- 2.1. Academic and student mobility on reciprocity basis;
- 2.2. Scientific, academic and general research;
- **2.3.** Mutual participation in programs, research projects, scientific and academic cooperation;
- **2.4.** Mutual academic promotion of parties in national and international programs and projects of scientific research;
- 2.5. Training and professional specialization.

Article 3. FORMS OF COOPERATION

Cooperation between Parties may include the following forms:

- **3.1.** Annual meetings or up on necessity, between groups of teachers and students in order to analyze and solve problems related to the implementation of the present Agreement;
- **3.2.** Promotion and reception of staff of the Parties as associate professors and honorary members;
- **3.3.** Academic and students participation in organizing and conducting forms of postgraduate and postdoctoral specialization, mutual participation in the examining of PhD candidates and approval of doctoral and master theses under the Parties own regulations;
- **3.4.** Academic staff from both institutions will be allowed to conduct doctoral students in the partner institution, the parties will see that the profile of graduate studies corresponds to the scientific themes;
- **3.5.** Library cooperation in exchange of books, monographs, textbooks, magazines, courses and other educational materials, setting the minimum number of copies and person responsible for this exchange;
- 3.6. Mutual editing and printing of books, monographs, magazines, etc.
- **3.7.** Promotion and development of student and academic mobility between Parties.

Article 4. DURATION OF AGREEMENT

The present agreement was concluded for an unlimited period and shall enter into

force upon the last signature and may be terminated any time by any Contracting Party giving a written notification.

Article 5. DISPUTE SETTLEMENT

All controversies on the interpretation and performance of the present Agreement shall be settled through consultations between the contracting Parties.

Article 6. FINANCIAL PROVISIONS

Contracting Parties may provide financial means within their budget necessary for the performance of the present Agreement. Financial aspects will be agreed between the contracting Parties and by endorsement.

Article 7. FINAL PROVISIONS

- 7.1. In order to achieve the above mentioned goals, the parties will form a permanent group of coordinators, from part of ASEM, COMU.
- **7.2.** The present Agreement may be completed and modified by mutual written consent by any of Parties. The agreed amendments shall enter into force upon signature by the Parties and be an integral part of this agreement.
- **7.3.** The present Agreement is signed in two copies, wherefrom each side gets one copy.
