AGREEMENT FOR A BILATERAL COOPERATION

BETWEEN

BAKU SLAVIC UNIVERSITY

AND

CANAKKALE ONSEKİZ MART UNIVERSITY

This Agreement for a Bilateral Cooperation is signed between Baku Slavic University and Canakkale Onsekiz Mart University referred to collectively as "Parties".

By signing this Agreement, Baku Slavic University (hereinafter "BSU") and Canakkale Onsekiz Mart University (hereinafter called "COMU") hereby agree to promote international cooperation in education and research.

Article 1. Scope and Areas of Cooperation

- A. Cooperative relations under this Agreement will encompass mutually beneficial educational and scientific activities in order to establish contacts between the academic staff of both institutions and to promote international education.
- B. The areas of cooperation between BSU and COMU are as follows:
- Student exchange and study abroad programs;
 - Mobility of academic and administrative staff;
 - Joint research programs;
 - Joint educational degree programs;
 - Joint organization of seminars, workshops, conferences and other events;
 - Internship programs;
 - Exchange of publications and other scientific literature;
 - Organization of cultural events of mutual interest to the Parties.

Article 2. Terms of Agreement

- A. The cooperative activities under this Agreement will be based on the principles of reciprocity and mutual benefit.
- B. Each Party agrees to appoint an overall Coordinator for the administration of this Agreement.
- C. Both Institutions are responsible for keeping their contact details up to date.
- D. Each Party agrees to undertake all the necessary measures to ensure confidentiality and protection of personal data.

Article 3. Exchange Programs

- A. The content and method of cooperation in academic exchange of students and staff will be determined after discussion between university authorities.
- B. The Parties may accept applicants who qualify as undergraduate, graduate or PhD students for academic studies in the appropriate department.
- C. The Parties may organize mobility of academics and staff for professional development.
- D. All details (including financial) regarding arrangements for specific visits and exchanges as well as other forms of cooperation will be negotiated and set forth in writing for each specific case.
- E. Each Party will exchange publications and other materials of mutual interest.
- F. All participants in the exchange programs shall be required to meet visa requirements that pertain to perform academic / research work in the host country.
- G. Exchange students and staff will not be charged for any application or tuition fees at the host institution.



Article 4. Modifications to the Agreement Document

- A. Articles of this Agreement may be revised upon mutual consultation of both Parties.
- B. All modifications of this Agreement must be agreed upon in writing and signed by the representatives of both Parties.
- C. This Agreement is prepared in two (2) copies in the English language.

Article 5. Termination of the Agreement

- A. This Agreement shall remain in force for five (5) years.
- B. The Agreement may be renewed for two (2) consecutive periods of equal duration by a written notice.
- C. The Agreement may be terminated by either Party by giving the other Party a written notice.

- D. The termination of the Agreement will not affect the terms of ongoing activities unless otherwise agreed by the Parties.
