



## Memorandum of Understanding on Academic and Research Cooperation

Between

**ÇANAKKALE ONSEKİZ MART UNIVERSITY, TÜRKİYE**

and

**DONGDUK WOMEN'S UNIVERSITY, KOREA**

DongDuk Women's University, Korea and Çanakkale Onsekiz Mart University have agreed to sign the following protocol with the purpose of fostering cooperation, mutual understanding and development in the fields of education and research.

### ***Article 1: Fields of cooperation***

That cooperation will include educational and research activities in all the areas and disciplines offered at the two institutions.

### ***Article 2: Forms of cooperation***

Both institutions agree that cooperation will include;

- a. Exchange of academic members and/or researchers,
- b. Exchange of students  
\*\* Tuition fee is free for up to 3 students. More than 3 students, 50% of the tuition fee must be paid at DWU.
- c. Collaborative research and publication of the results,
- d. Exchange of scientific publications, reference data, academic literature and other materials for research and educational purposes,
- e. Organisation of joint seminars, conferences, projects, workshops and similar events.

### ***Article 3: Exchange of academic members and researchers***

Both institutions will endeavour to facilitate visits by academic members and researchers.

- a. Visiting academic members and researchers will comply with the administrative procedures required by the host university.
- b. Both institutions will provide assistance to visiting academic members and researchers in finding suitable accommodation.



- c. Visiting academic members and researchers will be able to use libraries and other facilities.
- d. Both institutions will provide opportunities for visiting academic members and researchers to audit lectures.

#### **Article 4: Exchange of students**

Student exchange will be open to all students registered at either institutions.

- a. Each institution will be responsible for the selection of exchange students, subject to final approval by the host institution.
- b. The exchange students will pay tuition fee at their home institution and then study at the host institution without paying further tuition fees.  
 \*\*Each host institution will waive tuition fee for the exchange students up to 3 students.

- c. Each institution will assist exchange students in finding suitable accommodation, however, that cost will be the responsibility of the exchange students.
- d. Each exchange student will be responsible for travel arrangements and any other additional charges, such as passport fee, visas, resident permit fee and personal expenses(**Dormitory, etc**).

\*\* With regard to exchange students, it is understanding that they are responsible for obtaining insurance in their home country prior to arrival.

- e. The exchange students will be required to obtain health and travel insurance and provide evidence to the host institution.
- f. Selection Processes are to be determined by each host institution, sensitivity to language skills will be important.
- g. Students interested in applying to DWU must have TOPIK Level 3 or higher to be eligible to study as an exchange student in their major department.

※ If students do not eligible TOPIK Level 3, will be enrolled in the Korean Language and Culture major department as an exchange students.

#### **Article 5. Funding**

Both institutions will provide financial support according to the possibilities available to either party, and otherwise seek to secure funding from other national or international sources. Details of the funding for each project will be discussed and decided upon by the two parties as the need arises and will be specified and detailed in working plans / sub-agreements.

#### **Article 6: Validity of the protocol**

- a. This protocol will come into force commencing from the date of signing by the both institutions and will remain in effect indefinitely, unless terminated by either party with prior written notice
- b. This protocol may be terminated with six months' prior written notice to the other institution, without prejudice to the completion of ongoing projects agreed in the working plans.
- c. The provisions of this protocol may be amended at any time by the mutual consent in writing of both universities.
- d. This protocol has been prepared in English original copies and each party will retain 2 (two) original copies.

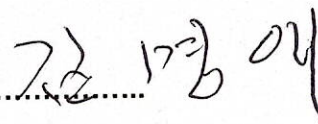
