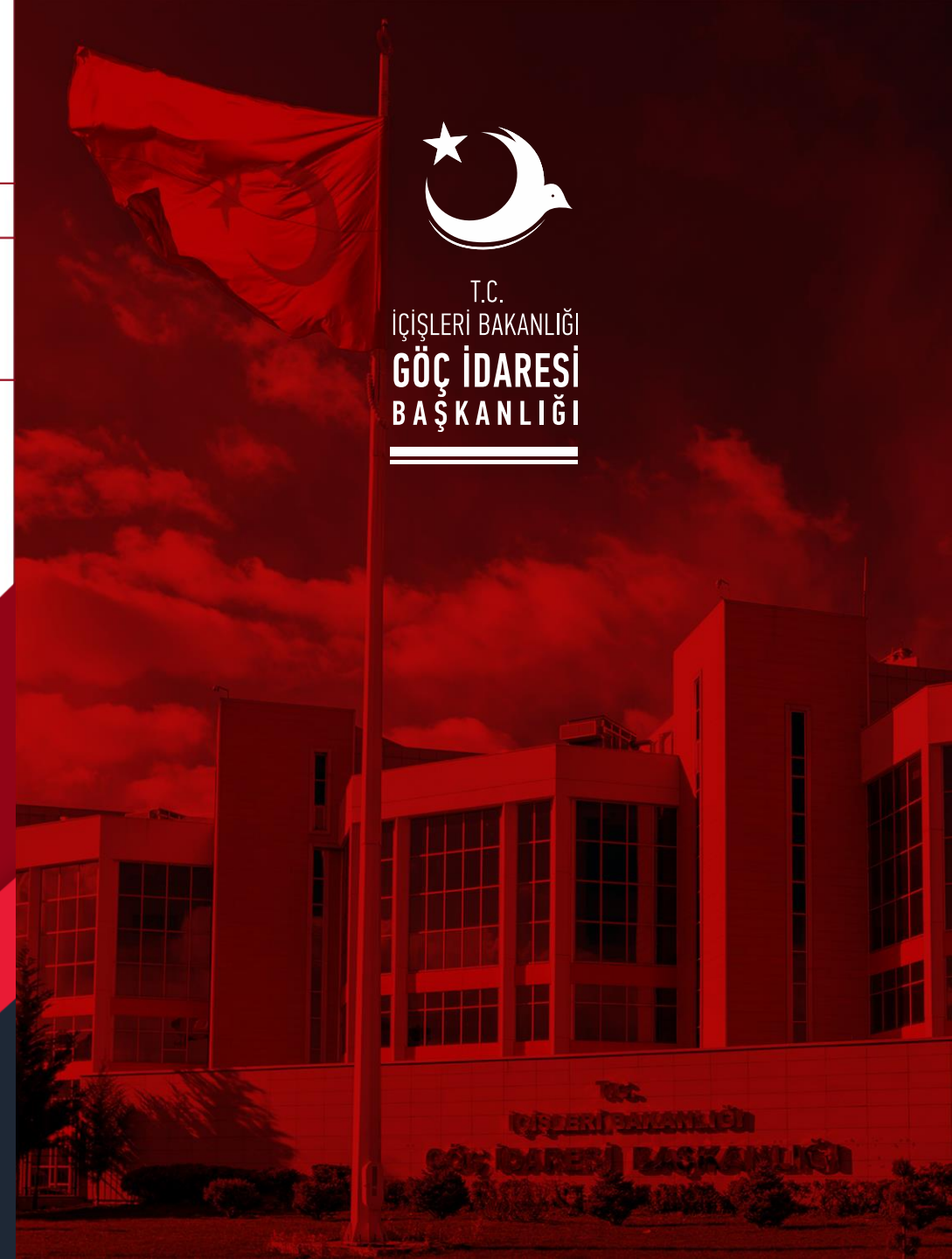

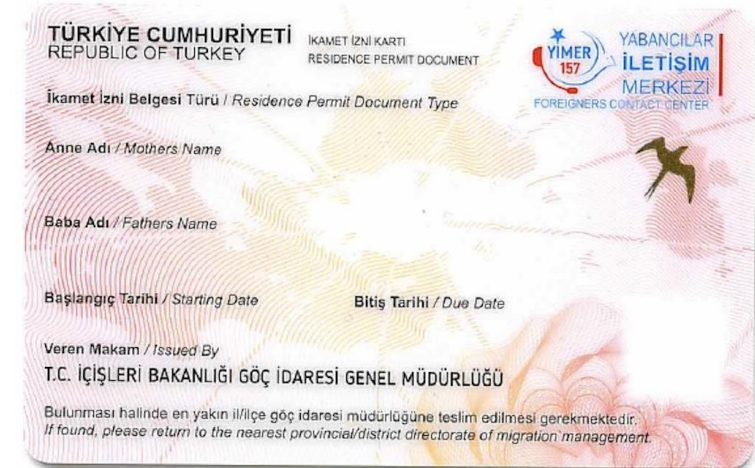

TYPES OF RESIDENCE PERMITS

in Turkey for more than the period allowed by the visa or visa exemption or **for more than ninety days** are required to obtain a residence permit. Residence permits are regulated in Articles 19-49 of the Law No. 6458 on Foreigners and International Protection.

1. Short-term residence permit
2. Family residence permit
3. Student residence permit
4. Long-term residence permit
5. Humanitarian residence permit
6. Residence permit for victims of human trafficking

There are **6 types of residence permits** ,



RESIDENCE PERMIT APPLICATION PROCESSES

- Applications can be made by making an appointment using the E-ikamet online system on the www.goc.gov.tr website. Application must be made according to the purpose of stay in Turkey.

To obtain a student residence permit, students can submit their documents to the university's international student office **without waiting for the appointment day and time**. Students with missing documents during application are given an additional period of up to 30 days by the university. After the files that have been processed at the university are sent to the Provincial Directorate of Migration Management, foreigners with missing biometric data are invited to the Provincial Directorate of Migration Management to obtain their biometric data.

- During the e-residence application, the name, surname and related information must be written exactly **as they appear in the passport** .
- **biometric photograph must be added** to the e-residence application form ,
- In cases where the passport is not written in Latin letters, **a notarized Turkish translation** must also be attached to the application.
- **accurate and complete** so that the administration can contact you when necessary and to avoid any grievances .

THOSE WHO CAN APPLY FOR STUDENT RESIDENCE PERMIT

6458 SK ARTICLE 38

- (1) Student residence permits are granted to foreigners who will study for an associate degree, bachelor's degree, master's degree or doctorate degree at a higher education institution in Turkey.
- (2) Foreigners who will receive primary and secondary education, whose maintenance and expenses are undertaken by a real or legal person, may be granted and extended one-year student residence permits for the duration of their education, with the consent of their parents or legal representatives.
- (3) The student residence permit does not provide any right to obtain a residence permit for the student's mother, father or other relatives.(*)
- (4) If the duration of study is shorter than one year, the duration of the student residence permit cannot exceed the duration of study.
- (5) **(Added: 28/7/2016-6735/27 art.)** Foreigners who will come to Turkey and study through public institutions and organizations may be given a residence permit for the duration of their education.

Residence permits are issued free of charge to students studying at Turkish schools or faculties.

DOCUMENTS REQUIRED FOR STUDENT RESIDENCE PERMIT

- Application form (with all pages)
- Photocopy of the passport's identity page, the page showing the passport expiry date, the visa page (if any) and the page showing the last entry stamp into the country.
- **4 biometric photos**
- **valid** Health Insurance as of the application date
 - E-signed/signed and stamped/sealed provision document received from SGK ,
 - to SGK to become a General Health Insurance holder (optional insurance), (*)
 - Private Health Insurance
- Documents regarding accommodation (Notarized rental agreement including a copy of the title deed and the landlord's ID document, signed and stamped document issued by the Dormitory Directorate, etc.)
- Student certificate
- Consent (for foreigners under 18 years of age)
- Residence permit document fee receipt paid to tax offices or online

- Following the submission of the required documents for a residence permit, each foreigner is given **an application document valid for up to 90 days, which provides the right to legally stay in Turkey until the residence permit document arrives** .
- provides
- **multiple entry and exit rights** abroad and can be used for a **period of 15 days** each time .
- It is a valid document for other public institutions and organizations.

HOW CAN I EXTEND MY RESIDENCE PERMIT?

An appointment must be made for residence permit extension applications through the e-ikamet system 60 days before the residence permit expires and in any case before it expires, and the applicant must be present on the appointment day with other documents.

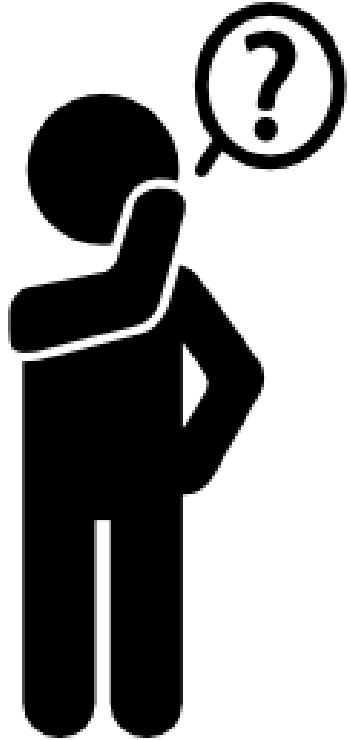

- **With the barcode number** sent to your phone via SMS, www.goc.gov.tr You can check the location of your card from the "Residence card inquiry" section on the website.
- PTT cargo goes to the address of foreigners twice. Residence permit cards of foreigners who cannot be found at their address are delivered to the Provincial Directorate of Immigration Administration.
- Foreigners who are not at their address can get their residence permit cards from the Provincial Directorate of Immigration Administration.



I RECEIVED MY CARD BUT MY INFORMATION IS INCORRECT, WHAT SHOULD I DO?

Apply to the Provincial Directorate of Immigration Management **IMMEDIATELY** .

IN CASE OF LOST, STOLEN OR WORN RESIDENCE PERMIT
WHAT TO DO?

In case of theft or loss; it is necessary to go to the nearest law enforcement unit and apply to our Provincial Directorate immediately with the report kept there . In this case, half of the residence permit fee and the document fee must be paid.

In case of wear and tear; residence permit fee payment receipt and petition. It is sufficient to apply with . In case of wear and tear, no additional residence permit fee will be charged.

- to notify our Directorate of any changes in information .

20 WORKING DAYS

- If you do not notify within the specified period, you may be subject to **administrative fines** . In addition, if it is determined that you have not notified your change of address, your residence permit may also be cancelled.
- After the residence permit is approved, foreigners **are required to come to the Provincial Directorate of Immigration Administration and register their address.** (The application must be submitted with a bill for electricity, water, natural gas, etc., a rental agreement or a signed and stamped document showing that the person is staying in the dormitory.)

- **case of university/faculty changes in the same province, the student** must notify the Provincial Immigration Administration of the change in his/her student status within 20 days, provided that he/she has not taken a break from school .
- If the student changes university, faculty or department in a different city, he/ she must make an e-residence appointment within 10 days and apply for a residence permit at the provincial directorate of migration management where the new university is located.
- **If the student has cancelled his/her registration and wants to continue to stay in Turkey, he/she must apply for a residence permit appropriate for the new purpose of stay, starting from the date of cancellation of registration.**
- the student **cannot graduate within the normal education period, he /she can extend the residence permit for periods of one year at most** and not exceeding the maximum education period. (A student residence permit cannot be issued after the maximum education period.)



- may be issued a short-term residence permit for a maximum of one year, once only, if they apply **within 6 months of their graduation date** . (Article 31/1-i of Article 6458)
- The 6-month application period does not mean that the foreigner can stay in Turkey without a residence permit.
